

The Clerk of the Circuit Court is required by Florida Statutes to charge for performing various duties and services. All checks should be made payable to Greg James, Clerk of Circuit Court. The Clerk's Office also accepts credit and debit cards with the VISA or Master Card logo, however when using one of these cards there is a non-refundable provider charge. The Clerk of Court does not receive any part of this fee.

The following schedule contains the most common transactions involving the payment of charges to the Clerk of Court. The Clerk's Office should be consulted for information regarding service charges not listed. Not all statutory fees are listed herein. These fees are based on the Florida statutes and are subject to change by the Legislature. In certain situations, other fees and charges may be charged by other governmental entities (the Sheriff's Office, for example) and the forms of payment accepted by them may be different than the Clerk of Court.
